GUIDELINES; 2023

GUIDELINES

*(Made under rule 3 paragraph 3.5 of the Schedule to the TaSUBa Establishment Order;
GN. No. 220/2007)*

The guidelines set forth hereunder shall apply to all attendees of the Festival and shall come into force from the date of signature by both of the undersigned.


1. All person aged under 18 years are not allowed to perform at night hours.
2. Alcohols or any intoxicating substance are not for sale to person under 18 years and the same is prohibited to accept any offer of such nature. ID may be requested.
3. Child must be accompanied by the parent or guardian and be properly cared. If found straying must be directed to the deployed Security Officers.
4. Pets are allowed if accompany by the owner; If aggressive must be muzzled. The Management shall not accept any liability for injuries or harm caused to any person by it or to it.
5. All firearms, weapons, knives, swords and other explosive materials and sharp objects are strictly prohibited save for the authorized Security Officers.
6. Lost or found properties in the Festival grounds shall be reported to the deployed uniformed Security Officers. Notwithstanding, the Management shall not accept any liability for the lost, missing or stolen property.
7. All acts, conducts and behaviors of sexual harassment, abuse, intimidation and or arousal are prohibited in the Festival grounds.

8. The Festival dressing code, save for performance costumes, is advised to be translucent casual, semi formal or formal of optional color or a unique creative outfits. To easily select attire material; weather forecast at the venue location may be gauged at that specific days and time for the scheduled Festival.
9. Business of illicit drugs and drugs abuse are strictly prohibited.
10. Parking is at the owner's risk and liability.
11. No attendee shall attack the performing artist on the stage notwithstanding any degree of temper. Excitement praises are allowed.
12. Abusing and vulgar language or words and offensive demeanor are not allowed.
13. Performance lineup is subject to change as deem fit.
14. Artist is not allowed to be under the influence of alcohol or body stimulant during the performance.
15. Life assurance, health and property insurance are advisable to performing artists and attendees. The Management shall not accept any liability for damage or injury suffered during the Festival.
16. Live or recorded performance and audience in still or video mode may be published during the Festival or thereafter.
17. Recorded performance or produced documentaries shall only be used in observance of the laws governing Copyrights and Intellectual property within the Tanzania domestic jurisdiction and the ratified International Treaties.
18. After closing the night performance, all attendees are advised and encouraged to revert to their homes or booked accommodations.
19. All accommodations are subject to personal arrangements and cost.
20. All acts of criminal nature under the domestic laws are strictly prohibited. Suspects may be searched, arrested and charged.
21. Respect to other attendees is mandatory.

22. Desirous arts and crafts exhibitor, beverage and food vender must at least 30 days prior procure an official permission for provision of the respective services within the Festival grounds. Upon approval, the applicant may be charged rent or fee rate as shall be imposed by the Management.
23. All the authorized and engaged Caterers and other Service providers must provide their respective services promptly and in a sanitary manner.
24. Every attendee is responsible for the safety and security of the personal effects. The Management shall not be responsible for any loss, damage or missing properties.
25. All litters must be properly disposed and binned.
26. Entrance fee may be imposed and charged in return of ticket. The lost ticket shall neither be refunded nor duplicated.
27. All foreigners must procure and own a valid permit from the relevant Government Authorities.
28. Person with communicable disease is advised to self isolation.
29. Smoking must be in an isolated area or in a designated smoking zone.
30. The scheduled Festival or pending programs may be affected by act or cause which is due to natural phenomenon or beyond the Institutional ability or control (*Force Majeure rule*).
31. In the event of an emergence, attendees are advised to listen and follow the direction of the rescue professionals.
32. Enterring to the Festival grounds shall be assumed and treated as consent to be photographed, filmed and observance of these guidelines.
33. The Management reserves right to alter these guidelines any time as deem proper.
